**CODE OF ETHICS FOR MEMBERS OF THE ALABAMA VECTOR MANAGEMENT SOCIETY**

Preamble: The purpose of the Alabama Vector Management Society is to promote the management of public health pests and arthropod vectors of disease, provide for the educational and scientific advancement of members, encourage scientific research in vector management and public health pests, promote an exchange of information among members, and to extend and develop public awareness and interest in the discipline.

Public health pest and vector management provides services that are extremely important to the health, welfare and progress of society. Those employed in the public health pest and vector management profession have the responsibility to render effective and professional service to humanity, in keeping with high standards of ethical conduct. Therefore, in striving to advance and maintain the honor and dignity of the profession, the Alabama Vector Management Society (AVMS) has established the following code to define the conduct and ethics due the profession. This code is binding on the membership of the AVMS.

AVMS members will use their knowledge and skill

for the betterment of human welfare.

- Members will, at all times, strive to maintain the public trust, and advance the standards and principles established by the AVMS.
- Members will cooperate in the exchange of information and technology for the growth and progress of the public health and vector management profession and the AVMS.
- Members will not cause dishonor to the Society through their actions while representing the AVMS.
- Members will comply with all laws and regulations that apply to our science and profession.
- Members will promote solidarity, harmony and support among members and fellow workers. They will not undermine, vilify, berate or otherwise intentionally injure the work, accomplishments, efforts or professional reputation of another.
- Members will not conduct or in any way participate in a fallacious review of the work of a fellow worker or other member.

## AVMS proposes amendments to by-laws



During the AVMS Executive Board Meeting on September 22, 2011, the Board discussed changing the AVMS by-laws to indicate in more detail the duties of the society's Treasurer and the official mailing address of the society. Any amendment to the bylaws must be proposed in writing by 30 days prior to the society's annual meeting. Voting to accept these amendments will take place at the annual business meeting. ### First Proposed Amendment

**Section Amended:** Article II. **Purpose:** to change address of principal place of business for the society. **Proposed Wording:** The principal place of business shall be located at Montgomery County Health Department, 3060 Mobile Hwy, Montgomery, AL 36108.

### Second Proposed Amendment

**Section Amended:** Article V, Section D. **Purpose:** to add official duty to Treasurer's existing responsibilities. **Proposed Wording (to be added at end of section):** The Treasurer shall file with the Internal Revenue Service accurate and timely tax documents by May 15th annually. Further, the Treasurer shall save tax documents and confirmation of submission of said activity with AVMS business records.

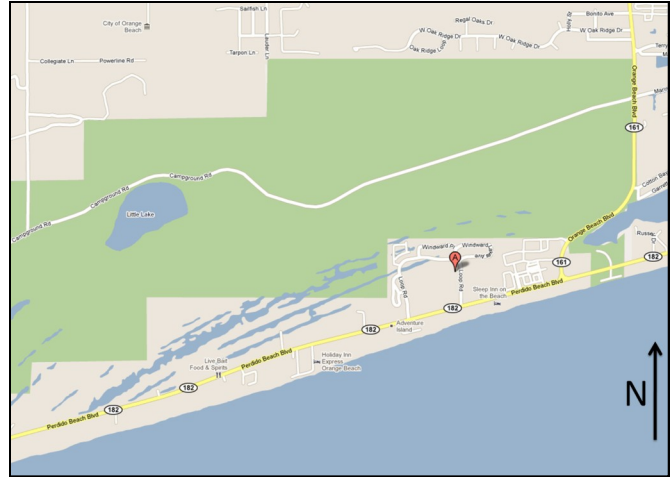

# Bat Exclusion Tips

Bats in the attic? The soffits? Louvered vents? Here is a tutorial for excluding them in some common scenarios.

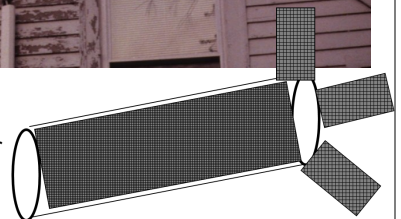
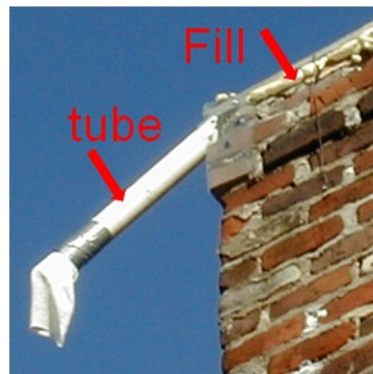
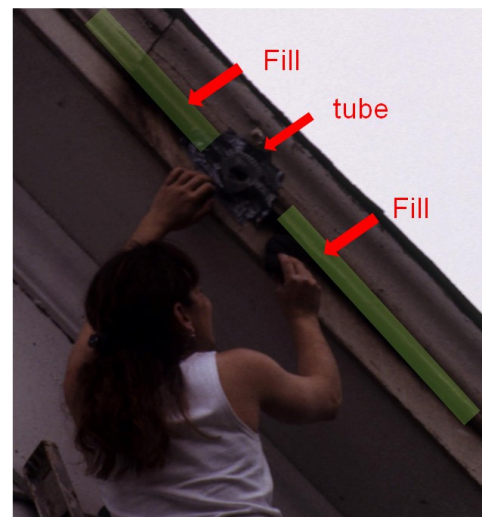
Most bats that inhabit human structures in Alabama are one of three species: Big brown bats, evening bats, and Mexican free-tailed bats. There are seven species of protected bats in Alabama under the Non-Game Species Regulation (220-2-.92), two of which are considered endangered. The three species mentioned here do not fall under the regulation. Luckily, we do not need to harm or harass these bats to exclude them from our structures. Well, unless you ask them...they may feel harassed when evicted from their cozy homes!

With bat exclusion, timing is everything. Bats are nocturnal and are active during the temperate times of year. In Alabama, we know that could be year-round, but generally speaking, bats stay put when nighttime temperatures hover in the 40's or below. So if you are going to exclude them, it needs to be during the spring and fall months, or exclusion may take longer. You should not attempt exclusion at all between late May and mid-August, as they may have young with them that cannot fly. If a bat can't fly, you can't exclude it! What will happen is you will exclude its flying mother, and leave the young bat trapped inside your attic with no chance of survival.

Find the places in your structure where bats are entering and exiting. Clues to watch for include brown stains (from the oil on their fur) on the adjacent substrate, droppings with tiny insect parts/scales in them on the ground below the entrance/exit or stuck to the brick or wood below the hole, strong odors, and occasionally sounds of scurrying and chirping. Some people are not able to hear the chatter/chirp of bats, so if you can, consider yourself lucky. If you have an idea where they are entering/exiting, make plans that night to watch with a flashlight to confirm the exit. Try to enlist the help of friends to monitor all the eaves, soffits, and trim around your house or structure to locate every place the bats are exiting. A bat can fit through a hole or crack the width of a dime diameter or larger. The next day, use a ladder or scaffolding to reach the hole, and cover it with a homemade excluder tube. Attach the tubes with staple guns, duct tape or temporary screws, making sure the base of the tube is firmly attached, with no gaps they might squeeze through. Then take the time to block or seal the rest of the gap (if it is larger than the diameter of the tube) in order to direct the bats to your tube as the only exit. The only exit for the bats will now be the very end of your excluder tube. Install an excluder tube over every exit you have identified. Later that evening at dusk until

past dark, watch with a flashlight to be sure the bats only fly out of the end of your tubes. Usually it takes them a bit longer to fly out because they are not used to this new "barrier" over their normal exit.

The tube functions as a one-way door..once the bats fly out, they cannot figure out how to fly back in. They key into the drafts of warm air coming from the original hole and try to enter at the base of the tube where the draft is coming from. But if the tube is installed firmly, they will be blocked from doing so. Leave the tubes up for a several warm nights to a week to be sure all the bats in the structure fly out (some bats may not fly every night). When you are certain no more bats remain, you can remove the tubes and permanently block/repair the holes. This might require installing new wood trim pieces or using caulking.

Attach tubes over all suspected exits and fill gaps around the tube using caulk or great stuff or steel wool so that bats can only exit at the end of the mesh or PVC tube.
